Donations Terms & Conditions (“Terms”)**

1. INTRODUCTION

- 1.1. Please read these Donations Terms and Conditions (“Terms”, “Terms and Conditions”) carefully before making any donations (“Donations”) on our website <https://minter.org/foundation> (“Website”) which is operated by Minter Development Foundation, a Not for Profit 501(c)(3) Corporation (“us”, “we”, “our”, or “Foundation”).
- 1.2. Contribution of Donations is conditioned on your acceptance of and compliance with these Terms. By making Donations you agree to be bound by these Terms. If you disagree with any part of the Terms then you should not make any Donations. These Terms and Conditions apply separately to each single donation that you make.
- 1.3. By completing the transaction on our website, you agree and understand that you are making a donation to Minter Development Foundation. The Foundation is operated exclusively for charitable, religious, educational and scientific purposes. The mission of the Foundation is to support the research and development of novel methods of value exchange for the public good.
- 1.4. We will use your donation at our discretion but within our stated charitable objectives.
- 1.5. We accept Donations in Bitcoin, Ether, BIP and other digital currencies. The payment is made via transfer of named digital currencies from your wallet to the corresponding wallet of the Foundation.
- 1.6. When processing your Donation, we may incur fees of third-party payment providers. By making Donation you agree that such fees will be deducted from your initial donation and only remaining amount will be used for charitable purposes.
- 1.7. We reserve the right to refuse or cancel your Donation if fraud or an unauthorized or illegal transaction is suspected.
- 1.8. When making a Donation you may be asked to supply certain information relevant to your Donation and identity including, without limitation:
 - your first name
 - your last name
 - your address
 - email
 - phone number
 - your wallet ID

- scan-copies of your ID document
- 1.9. You represent and warrant that: (i) you have the legal right to funds used to make the Donation; and that (ii) the information you supply to us is true, correct and complete.
 - 1.10. By submitting your information, you grant us the right to provide the information to third parties for purposes of facilitating the completion of your Donation.

 - 1.12. We won't share your personal details with any other third party other than is set out in our Privacy Policy. Our Privacy Policy forms part of these Terms and by agreeing to these Terms you are also agreeing to the way we use and protect your personal information in line with our Privacy Policy.
 - 1.13. We reserve the right to amend these Donation Terms and Conditions at any time. These Terms shall be governed and construed in accordance with the laws of Delaware, United States, without regard to its conflict of law provisions.
